# Input statement to the UN Zero Draft Terms of Reference: the UN Framework Tax Convention and Global Tax Governance: What changes are needed to enhance global tax governance?

On 24 June we submitted our input to the zero draft terms of reference. The zero draft is the first step towards a more inclusive and effective international tax cooperation. However, in this first step, it is important to give attention not only to the topics but also to the process. Main important question is how to ensure that this process is not questioned as it has been the case of the OECD/G20 and the BEPS Inclusive Framework. In the contribution, we have focused on the objectives, guiding principles and substantive elements of this UN Framework Convention. Input <u>here</u>.
